





## GUIDE DOGS ACCOMPANYING BLIND OR VISUALLY IMPAIRED PERSONS ARE PERMITTED IN FOOD RETAIL ESTABLISHMENTS

This circular seeks to remind all food retail establishment operators that guide dogs accompanying blind or visually impaired persons are permitted in food retail establishments under current legislation.

## Guide dogs are permitted in food retail establishments under the regulations

- 2 Under the Environmental Public Health (Food Hygiene) Regulations, live animals such as pets are not permitted to be brought into or kept in a food establishment, with the exception of pet cafés<sup>1</sup>. However, a food establishment licensee may permit any guide dog accompanying a blind or visually impaired person to be brought into the dining or refreshment area or toilets of the licensed premises.
- Within the food establishment, the guide dog is required to be: (i) kept under proper control; (ii) restrained from straying or causing annoyance or nuisance, or from damaging any property; and (iii) held in a leash. The guide dog should also not be fed within the food establishment unless it is a pet café. We have worked with Guide Dogs Singapore to remind guide dog users to comply with the regulations involving the use of guide dogs.

## Guide dogs support persons with visual impairment

Guide dogs are specially selected and trained to help blind or visually impaired persons travel independently and safely. Guide dogs can be identified by the harness worn on their body, which may carry messages such as "Guide Dog at Work" and "Do Not Distract". Please refer to the following examples of guide dog identification:

<sup>&</sup>lt;sup>1</sup> Pet cafés are food shops where patrons may bring their pets along when they dine in these food shops. A pet café licence is issued to such food establishments.
